## Personal Information Collection Statement Regarding Membership Application

Wah Yan (Hong Kong) Past Students Association Limited (referred to hereinafter as the "**Company**") recognizes its responsibilities in relation to the collection, holding, processing, use and/or transfer of personal data under the Personal Data (Privacy) Ordinance (Cap. 486) ("**PDPO**"). Personal data will be collected only for lawful and relevant purposes and all practicable steps will be taken to ensure that personal data held by the Company is accurate. The Company will take all practicable steps to ensure security of the personal data and to avoid unauthorized or accidental access, erasure or other use.

### **Purpose**

It is necessary for the Company to collect your personal data which may be used, stored, processed, transferred, disclosed or shared by us for purposes ("**Purposes**"), including:

5. complying with the laws of any applicable jurisdiction; and
6. other purposes directly relating to any of the above.

### **Transfer of Personal Data**

Personal data will be kept confidential but, subject to the provisions of any applicable law, may be provided to:

1. any of our affiliates including overseas Chapters, any person associated with the Company, our mother School and their legal advisors;
2. any agent, contractor or third party who provides administrative, technology or other services to the Company and/or our affiliates including overseas Chapters and who has a duty of confidentiality to the same;
3. any Government department or other appropriate Governmental or regulatory authority in Hong Kong or elsewhere; and
4. in lawsuit matters, the Court, the opposition party and their legal advisors.

Transfer of your personal data will only be made for one or more of the Purposes specified above.
